- 2. To report to the chapter a list of all eligible members for the upcoming election at the September chapter meeting.
- 3. To present the slate of candidates, which shall serve as the official committee report, at the October chapter meeting and voted on at the November chapter meeting.
- 4. To create the ballot for the election.

Takeaways:

- The committee has coordinated with Madame Basileus to retrieve and review the list of active Sorors who have attended conferences/summits/Boule within the past year.
- The committee has created a Google Form to capture information from Sorors to assist in identifying and qualifying members eligible to run for office.
- An email will be sent out after the September chapter meeting to allow Sorors to advise the committee of their interest in running for office and to provide additional documentation (AKA resumes, certifications, etc) where applicable.

As per the Chapter Bylaws:

3a. To be eligible for an office other than Basileus, a soror shall have been a financial member of Rho Kappa Omega for at least twelve (12) months immediately prior to candidacy. She shall have actively served on at least one (1) committee and attended at least one (1) Regional Conference, Boule, Cluster IV Leadership Conference or Leadership Seminar within the twelve (12) months immediately prior to candidacy. She shall be familiar with the Alpha Kappa Alpha Constitution and Bylaws, Manual of Standard Procedure, the Rho Kappa Omega Chapter Bylaws and shall have knowledge of the Sorority, its history, philosophy and procedures.

3b. To be eligible for the office of Basileus, a soror shall have been a financial member of Rho Kappa Omega for at least thirty-six (36) months immediately prior to candidacy. She shall have attended at least seventy percent (70%) of chapter meetings and shall have actively served on at least two (2)

committees or served as an officer for the twenty-four (24) months immediately prior to candidacy. She shall have participated in the program activities of the chapter. She shall have attended at least three (3) of the last five (5) Regional Conferences and shall have attended at least one (1) Boule in the five (5) years prior to candidacy. She shall have attended at least one (1) leadership seminar or conference or Cluster IV Leadership Conference within the past twenty-four (24) months immediately prior to candidacy. She shall be familiar with the Alpha Kappa Alpha Constitution and Bylaws, Manual of Standard Procedure, the Rho Kappa Omega Chapter Bylaws and Robert's Rules of Order, Newly Revised.

3c. To be eligible for the office of Graduate Advisor, a soror shall have been a member of Rho Kappa Omega for at least twenty-four (24) months immediately prior to candidacy. She shall not have been suspended for hazing and shall be at least a five (5) year post graduate from an undergraduate college or university program. She shall have attended at least one (1) of the last two (2) Boules or one of the last two (2) Regional Conferences and must be certified by the Directorate approved Alpha Kappa Alpha Graduate Advisor Certification Program.

Introduction of the Supreme Basileus (Soror Candice Glover, Xi Omega) The Supreme Basileus was introduced by her daughter, Soror Candice Glover via video outlining her accomplishments as Supreme Basileus followed by a performance by the TSU Marching band escorting Madam Supreme to the stage while she twirled a baton in marching order fashion.



<u>Report of the Supreme Basileus</u> (Soror Glenda Glover)

Madam Supreme centered the theme of her report on two legacies, Roots and Wings. She spoke about her accomplishments in the 5 Program Targets, Membership, MIP, and Sisterly Relations. She also noted the 2018 promises that she delivered on including the International Day of Prayer (4th Sunday of August) and establishing and International Chaplain.

On March 11, 2020 she established the Pandemic Taskforce to guide the sorority through the pandemic simply and safely with a focus on masks, sanitation, and vaccination. Although Regional Conferences were postponed n 2020, programs and operations were not interrupted with virtual formats morphing into hybrids as the pandemic resolved. On March 4, 2022, all operations resumed and our ability to soar with wings was not affected.

During the pandemic 2,273 members contracted COVID and 46 have become Ivy's Beyond the Wall. A moment of silence was given in their honor.

The report included a video presentation with the following highlights:

<u>HBCU</u>: The sorority raised 1 million in 1 day for 4 consecutive years for HBCU for Life with 2.3 million raised last year. HBCU endowments were established on all HBCU campuses totaling **\$5,702,155** and counting.

<u>Health and Wellness</u>: The sorority established the first mobile mammography unit to be owned by a greek organization with over 184,000 miles traveled over 72 states with more than 4,692 mammograms performed. Additionally, COVID outreach was performed and health services like the Mississippi Healthcare Project.

<u>Membership</u>: The sorority provided a stimulus with a \$25 reduction in per capita during the pandemic. Total membership increased by 40,000 with 33,000 new members and 112,000 Financially Active Members to date.

<u>Disaster Relief</u>: The sorority provided \$170,100 in donations to 300 sorors.

<u>Connection and Social Action</u>: The focus was on equal pay, federal judicial appointments, when we all vote, and the condemnation of unjustified killings. With AKA Leads, voter turnout increased for blacks with 250,000 registered to vote in the 2020 elections. With the Election Protection Initiatives, 16,000 responses were received from Sorors willing to work to protect voters' during the elections.

<u>Set it of Stroll</u>: Is now the nationally recognized stroll for AKA.

<u>Undergraduate Activities</u>: 50 appointments to International Committees were noted and 2021 Virtual Commencement Celebrations held across 10 regions.

<u>History of AKA</u>: The 20 Pearl Documentary narrated by Soror Phylicia Rashad is the first full length feature film by a greek letter organization to be distributed with a 20 Pearls Book. The conversion of founder Ethel Hedgemon Lyle's home to the Ethel Hedgemon Lyle Museum is also underway.

<u>Executive Leadership Academy</u>: The two day leadership academy produced 49 executive fellows.

Economic Impact: \$1,820,000,000 in total Economic Impact.

<u>Chapter History Book</u>: Volume 1, Undergraduate and Volume 2, Graduate have been published and sent via email to members.

<u>Programs, Membership, Operations</u>: As of June 30, 2022, 113,000 Financial Members. Over 100,000,000 in assets in all AKA related entities. 74 million in assets in AKA, 27 million in EAF and 1.4 million in housing totaling 102.7 million up 94% from 53 million since July 2018.

- 18th Supreme Basileus, Soror Mattelia B. Grays brought greetings via video as she could not attend in person. She attended her first Boule at Dillard University.
- 25th Supreme Basileus, Soror Norma Solomon White recalled the 60th Boule in Orlando, Florida in 2002. She noted that there is "No gathering like BOule" and welcomed "newbies." She reminded us that "We want to demonstrate sisterly love in all that we do."
- 28th Supreme Basilues, Soror Carolyn House Stewart acknowledged 29th Supreme Basileus, Soror Dorothy Buckhanan Wilson's birthday and that the number 70 represents introspection and inner wisdom. She reminded us that "equality is a mandate and our participation is not an option."
- 29th Supreme Basileus, Soror Dorothy Buckhanan Wilson acknowledged that she shares a birthday with the 23rd Supreme Basileus and noted that Boule represents the "power, impact and prestige" of our sorority. She noted how wonderful it is to be "Back together again" and charged us all to have magic, learn and enjoy, meet five sorors, show gratitude and exude warmth.

Recommendations from the Directorate were moved to Plenary 5.

FOURTH PLENARY SESSION Soror Jasmine Butler

The Fourth Plenary Session was called to order at 9:07 am on Wednesday, July 13th, 2022. Madam Supreme Basileus Glenda Baskin Glover presided over the opening agenda items following a musical prelude from the 70th Boule Choir. Madam Supreme called upon Soror Brenda L.G. Smith, International Day of Prayer Committee Chair to provide the meditation. The meditation titled "The Esther Factor" was derived from Esther 4:14. Madam Supreme gave special recognition to all Frontline workers and Military Sorors (Active & Retired) in attendance. Madam Supreme gave recognition to all committees under her administration followed by another musical selection from the 70th Boule Choir.

Madam Supreme announced a change in agenda. The Tellers Report will be moved from Plenary Session 5 to Plenary Session 4.

Report of the Program Committee

Soror Ora B. Douglass, International Program Committee Chair presented the Program Committee report. She reported on each of the five program targets as follows:

Target 1: HBCU for Life: A Call to Action

Sorority raised \$1 million dollars in one day 3 years in a row. #CAP exceeded its goal of enrolling 50,000 students in less than two years with a current enrollment of 178,204 (114,099 Female/64,201 Male) students.

Target 2: Women's Healthcare and Wellness

Sorority walked a total of 909,629,492 steps with Madam Supreme. Provided 5,360 Pink Goes Red programs; 2,075 Caregiver programs; 4,161 Breast Cancer Awareness programs; Mobile unit helped 15,352 women while providing mammograms to 2,699 and of those, 269 were referred for additional testing.

Target 3: Building your Economic Legacy

Sorority partnered with Regions Bank for 3 years. Hosted 5 million workshops. Spent \$59 million in Black-owned businesses. A total of 78 million in volunteer hours.



Target 4: The Arts!

644,851 individuals exposed to the Arts. Sorority hosted 3, 297 Harlem Renaissance programs and 4,415 Black Arts Movement programs.

Target 5: Global Impact

The goals of 500,000 pairs of shoes were exceeded. Sorority collected 633,365 pairs of shoes and 169,406 LionsClub eyeglasses. The Sorority exceeded the target goal of 75,000 dresses and shirts. Sorority collected 178,000 dresses and shirts (126,429 pillowcase dresses/40,471 pillowcase shirts). A total of 1,310,619 refugees were assisted under the target program.

A total of 4 million hours completed from Impact Days. Of them, 47,676 Inactive Sorors hours and 3,816,274 total volunteer hours.

Report of the Membership Committee

Soror Tracey L. Morant Adams, International Membership Committee Chair presented the Membership Committee report. Under the committee's mantra "Membership is Pearl-fection", she reported that the Sorority has the highest number of active members in the Sorority's history. As of July 2022, Alpha Kappa Alpha Sorority, Incorporated is 113,044 active members strong! The committee implemented the Reactivation in Workplace initiative to assist in getting inactive sorors back into active membership. The Online Transfer Verification Form was created and provided to assist in the transition of sorors from Undergraduate to Graduate Membership, Transfer in Chapter Membership and General Membership status. The committee implemented a membership stimulus package in 2020 to assist with membership dues during the pandemic. Revised the Mentoring guide book in 2020 and created a new milestone in membership called "Pearl" representing 65 years of membership. The committee participated in over 125 conference workshops. Under the committee's 2021-2022 initiative "Reactivation Workplace Day", 33,095 sorors reactivated!

<u>Report of the MIP Committee</u>

Soror Cynthia F. Finch, International Membership Intake Process Committee Chairman and Soror Yolanda Murdock, Co-Chairman presented the MIP





Committee report. The committee's mantra "Never Forget How it Made You Feel" was the focus on making the intake process chapter, Soror and candidate friendly.

The 3 P's: Plan, Prepare & Pivot- Surviving through a Global Pandemic was created to assist in creating and implementing a modified MIP Process.

In 2019, the Sorority inducted 12,530 new members; in 2020 1,255 Undergraduate members; in 2021, 8,651 new members and in 2022, 3,291 for a total of 25,757 new members. It was also noted that the "Twenty Pearls" documentary has been added to the MIP in the Virtual environment.

Report of the Connection and Social Action Committee

Soror Roslyn M. Brock, International Connection and Social Action Committee Chairman presented the Connection and Social Action Committee report. For the 2020 Census, Sorors volunteered and participated in various civic engagements within their respective regions which increased the Sorority's Twitter followers to 1,600. On the 50th Anniversary of Bloody Sunday, over 25,000 participated for John Lewis Voting Rights Act. The Virtual and In-Person AKA Day at the Captiol had over 14,000 participants. GOTV (Get Out The Vote) Education and Registration initiative won the Sorority the "When We All Vote" award at the Inaugural Culture of Democracy Summit in June 2022. There was an increase in political representation during elections resulting in our first ever African American Female Vice President of the United States, Kamala Harris and first ever African American Female Supreme Court Justice Ketanji Brown-Jackson. The committee implemented the National Election Protection Initiative. Report concluded with quote "Until black women are free, none of us will be free." Barbara Smith.

Report of the Undergraduate Activities Committee

Soror Jasmyne E. McCoy, Second Supreme Anti-Basileus, Sorors Alysee Guerrier and Jasmine Williams, Undergraduate Members-at-Large presented the Undergraduate Activities report. The committee's mantra "R.E.A.C.H. -Resilience, Excellence, Ambition, Connection and Heart" were their focus. Reported that the modified membership process brought in thousands of new members. Conducted a virtual commencement celebration in 2021 for graduates via YouTube and Facebook. PPE (Pretty Protective Equipment) kits raised nearly \$40,000 for the AKA EAF UAC Fund. Kits sold out in 1 week! Fall & Spring Skee-Wee weeks were conducted successfully. Both Undergraduate Days of Prayer "The Best is Yet to Come; A Change is Yet to Come" produced an audience totaling 50,000 viewers. Launched two social media campaigns (Self Care Saturday & Workout Wednesday).

Report of the Chapter History Book Committee

Soror Lauren N. Peebles, International Chapter History Book Project Committee Chairman presented the report. Advised that these books are one of the few to include Chapters in the history. The two-volume history book titled "Writing the Untold Stories of Our Chapters" highlights the need for chapters to tell and share their stories. Each chapter will have one hard copy of the history books for chapter records and digital copies are available with searchable pages and a comprehensive index.

Report of the Economic Impact Committee

Soror Vereda Williams, International Economic Impact Committee Chairman presented the Economic Impact Committee report. She advised that the committee determines the economic impact the Sorority has on a local, regional and international level. From July 2018-April 2022, they developed a roadmap, illustrated the financial power of the Sorority and allows for financial efficiency



when working in communities. The tool used to implement the objective of the committee was called IMPLAN- an econometric software package which tracked individual soror impact surveys, the Sorority's spending power, local chapter community spending and regional and national conference spending.

FIFTH PLENARY SESSION

The Fifth Plenary Session was called to order at 2:33pm on July 13, 2022 by Soror Glenda Glover followed by a meditation by Soror Lottie Otto, International Spiritual Oversight Committee member—Gamma Xi Omega Chapter, who began with a roaring message/conviction to Sorors asking loudly and repeatedly at first, "If it had not been for the Lord on your side, where would you be?!" Sorors were asked to engage their neighbor in a series of questions (i.e. won't he do it?) as Soror Lottie began passionately running about in praise (circling the front of the room) revisiting the microphone to praise



God for being almighty, blessing us all, and anointing new leaders to come forward in leadership and service.

<u>Regional Director Greetings</u>

Madam Supreme began a regional roll call, acknowledging each region, as members cheered with enthusiasm as their regions were called. Madam Regional Director, Mary Lamar Bentley, was first to address her region, reminding the Boule that the Notable North Atlantic Region is the origin of our beloved sorority and therefore will forever hold special significance. She went on to thank Madam Supreme for the work the region has been able to achieve under her leadership and ended her greetings by quoting her mantra "Leading on a High Note". She was followed by nine other greetings from the regional directors of the remaining regions. All were well received with cheers and excitement.

Boule Reports

Soror Danette Reed, Incoming Supreme Basileus, reported that a hard copy of a book titled "Boule Reports" would be distributed before conference end which would serve as a comprehensive resource for all reports from the Directorate.

Madam Supreme shared a surprise was coming and invited Soror Stacy Jackson to come and address the room to share the news and then recanted with "Still working on it"

<u>Report of the Executive Director</u>

Soror Cynthia Howell, Executive Director began with a Registration and Delegate report. Soror Howell began by dedicating the report to her recently deceased mother, acknowledging that this would be her first Boule without her present.

Soror Howell, presented a video. The video began by speaking to the need to take risks and the impacts of the pandemic required AKA to take risks in order to pivot and successfully overcome challenges which yielded a myriad of impressive results including, but not limited to:

28,000 members participated in our first hybrid conference;



- MIP working in overdrive (110,778 exceeding previous 89,000 by 24%, as of June 14, 2022, 112,171—highest financial active membership in history, record number of evaluations and initiations);
- Finance and Accounting received an unmodified opinion for 2021 audit;
- IT help desk remained active providing support, e-blasts, website updates, virtual certifications, installing new AMS system;
- HR Dept. overseeing 36 corporate staff members (over half with over ten years tenure, six over 20 years);
- Facilities team managed online orders, inventory, shipping (Ivy Center pictured and noted as immaculately maintained and improved);
- Dept. achievements, Leadership Seminars, Leadership Fellows, 2 Boules, Vendor Management—working with intellectual property attorneys prior to Dec 1 2021—now have 297 licensed vendors. Sorors were reminded to only purchase from AUTHORIZED vendors—who must use their websites and Facebook (no other social media platforms have been authorized for the sale of AKA items); and,
- Publications and Graphics continued—Boule documents, mailings, Ivy Beyond the wall, Ivy Leaf quarterly.

Soror Howell ended her report video with a call to action reminding us that this season has calls for greater care, greater resolve, greater consideration for one another in work culture as we seek to problem solve and find ways to do things better in service to our members, transformational goals, and to live up to the challenges ahead. They will live up to their motto "We get it done." —The report was concluded by submitting officially to Madam Supreme.

Madam Supreme's Surprise

A personal and a professional bio was read to introduce Legacy Soror and Honorary Member, Robin Roberts, inviting her to address the Boule. Members in the audience stood and she began by bowing in honor to Madam Supreme and opened with a big "Skee-Wee". She shared her pride for the sorority, blessed Madam Supreme, and (with emphasis) all who serve Alpha Kappa Alpha. She spoke of her mom, Howard alum and Soror. Soror Robin told the Boule that she believed her mom was cheering us on alongside the founders of

AKA as we continue their legacy of service. Soror Robin went on to express gratitude and acknowledged the head of ABC News' leader who is also a soror. She closed her remarks by thanking the Boule for the honor, rights, and privileges of being a soror before exiting the podium. After which she personally greeted members of the DAIS. The audience looked on and observed as they moved into formation to take a picture

Directorate Recommendations

Madam Supreme informed everyone that we would now move into voting on directorate recommendations and made remarks about the seriousness and the responsibility of the moment. Madam Supreme Grammateus, Soror Chelle Luper-Wilson, came forward to introduce each Regional Director to introduce their recommendation to the Boule.

1. To dissolve Sigma Lambda Chapter Swarthmore College.

- (college has discontinued greek life, chapter has had members less than 8 members for three consecutive years, inactive since 2016, meets dissolution requirements) by NA Regional Director, no second required, Madam Supreme called for discussion before calling for the electronic vote.
- Boule Delegates were invited to make a motion to preserve the name of the chapter, and the motion was presented from the floor. Madam Supreme asked for a second and the call was answered.
- Madam Supreme interrupted advising that we would first vote on the dissolution and then return to the motion once that vote was concluded.
- The motion to dissolve the chapter carried with 92.21% of the Boule delegates voting YES. The motion to preserve the name of the chapter for future use was presented to the Boule and carried with 94% of the Boule voting YES.
- 2. To expel Soror Alecia Johnson, Gamma Pi Omega Chapter, Fort Valley, GA for felony conviction for prostitution.
 - Soror Carolyn Randolph, South Atlantic Regional Director, presented a case for expulsion for Soror Alecia Johnson. As Graduate Advisor, Soror Alecia was arrested for a prostitution ring. The story was nationally covered, shedding negative light on the sorority. The investigation was



conducted with the accused not responding or participating in the investigation and later plead guilty to six (6) counts of related charges.

- Motion mad to accept the recommendation. Motion passed with 3622 yes votes, 100%. Soror Alecia Johnson is expelled.
- 3. To expel Soror Pamela Barnes, Beta Pi Omega, Little Rock Arkansas for misappropriation of funds.
 - Soror Joya T. Hayes, South Central Regional Director, presented a case for expulsion for Soror Pamela Barnes. As Graduate Advisor, she contacted a bank to order checks and a debit card for the chapter (not permitted for chapters). A Soror who worked at the bank discovered the charges and reported them resulting in an investigation of misappropriation/mismanagement findings—ignored documents re: financial management, admitted that she withdrew funds without two signatures, did not allow officers to prepare financial reports (prepared herself and submitted for presentation), forged signatures, made unauthorized purchases, filed false claims with insurance company to get funds and accepted responsibility; She was charged and convicted, with felonies and fees.
 - Motion made to accept the recommendation. Motion passed with 3530 yes votes, 97.73%. Soror Pamela Barnes is expelled.
- 4. To expel Soror Safona A. Calderon, Xi Nu Omega Chapter, Chicago, Illinois for misappropriation of funds.
 - Soror Sonya L Boyen, Central Region Director, presented a case for expulsion for Soror Safona A. Calderon Xi Nu Omega; Northeastern IL University Grad Advisor (Pi Nu), member Xi Nu Omega chapter; report brought by member; withdrew closed funds illegally closed accounts, and forged signatures on MIP documents, checks, etc.; During the investigation it was determined that she had altered statements/documents; 3 people spoke at mics—2 of 3 in support of motion to expel.
 - Motion made to accept the recommendation. Motion passed with 3,323 yes 97.08%. Safona Calderon is expelled.



- 5. To expel Soror Rosalind Hines, Kappa Beta Omega Chapter, Vacaville, California for misappropriation of funds.
 - Soror Shelby D Botany, presented a case for expulsion for Soror Rosalind Hines, Kappa Beta Omega; \$85,000+ misappropriated funds; no appeal and actions resulted in multiple chapter accounts being depleted; chapter retained an attorney and entered into an agreement for repayment; Soror Hines made payments initially and then wrote a new letter disagreeing with the amount owed but ultimately repaid the funds.
 - Motion made to accept the recommendation. Motion passed with 3,214 yes (93.57%). Soror Rosalind Hines is expelled.

Report of the EAF, Executive Director

The EAF Executive Director, Soror Ericka Everett, opened with a brief historical overview of the EAF and its founders (3 pictured on the Boule screen); Noted EAF is the largest 501C3 organization owned by minority women. The mission and vision were projected and reviewed (read to the Boule as written). She proceeded to describe the role of the EAF Executive Director and shared three goals guiding the work from 2018-22: 1. Increase philanthropic efforts, 2. Broaden and uplift the brand internally and externally, and 3. Showcase HBCUs (\$8.9M awarded to 102 schools over administration). She went on to share EAFs four (4) core program areas: scholarships, endowments (New high 400 \sim \$22M), matching gifts and CFCs. 2022 Awardees and categories for levels of given were reviewed (names available on website and on a plaque at headquarters). The EAF celebrated increasing the number of "Platinum" chapters (those donating above and beyond requirement), 337 were celebrated earlier at the EAF Breakfast with the North Atlantic Region accounting for sixtyone (61) of those chapters. Soror Everett closed by acknowledging the Board of Directors, Regional Directors, and her corporate office team. She extended gratitude to Dr. Glover and invited members to monitor the website for regular updates/information or any need to contact the EAF for support-see akaeaf.org

Special Recognition of Leadership Fellows

Madam Supreme returned to the podium and announced her desire to celebrate Leadership Fellows (200—two recent classes combined), largest





class in the program's history). Madam Supreme invited the Sorors present to come forward for recognition before the Boule. Soror Eleasha Pegues-Spearman, Committee Chair, came forward to seal their praise. She introduced committee members and shared some of the recent accomplishments of program alums (newly elected 2nd Supreme Anti-Basileus, Under Grad Rep At Large; Interns at ABC; Newly crowned Miss North Carolina). Madam Supreme closed the recognition by asking program alum to stand and thanked all those who served on a committee from 2018-22.

Special Recognition of the Executive Leadership Academy

Madam Supreme arrived to the podium eager and proud to share the success of the Executive Leadership Academy designed and launched during her time as Supreme Basilues to develop leaders and to create a pipeline to the csuite/senior executive roles. She reviewed the program purpose/definition and shared that in October 2021 the academy saw 25 participants and hosted 24 participants in the Spring of 2022. All executive fellows were pictured on slides reflecting their names, chapter, and roles—read aloud to the Boule by Madam Supreme. She proceeded to display and introduce the Academy's faculty as well as members of her treasured advisory committee. All requested to lead/support within the program accepted the call. There have been numerous celebrations among participants including but not limited to promotions, new positions, raises, new business launched, and board appointments. Members present joined Madam Supreme for a picture.

Boule announcements were given by Soror Schylbea Hopkins, Supreme Hodegos and the Fifth Plenary Session was recessed.

SIXTH PLENARY SESSION

Soror Danielle Crim

The Sixth Plenary Session was called to order at 9:25AM on Thursday, July 14, 2022 Soror Glenda Glover. Secret Service is present as Madam Vice President Kamala Harris was in the building. The session was originally scheduled to start at 8:30AM but due to the extra security measures causing long delays to enter the session, Madam Supreme delayed the start time.

The first agenda item was a video update on the Ethel Hedgemon Lyle Museum for African American Women located in St. Louis, Missouri. Alpha Kappa Alpha is well positioned to move forward with efforts to restore the home owned by Ethel Hedgemon Lyle and converting it to a museum which will provide another opportunity for Alpha Kappa Alpha to share our story, highlight HBCUs and feature prominent African American women who have been ceiling breakers history makers. Phase I is completed.

The rededication ceremony started at 9:39AM, led by First Supreme Anti-Basileus Soror Danette Anthony Reed. Sorors were asked to remove hats, tiaras, and stand to our feet. There were several call & response prompts. They hymn was sang. The rededication ceremony ended at 9:54AM.

The Ivy Beyond the Wall Ceremony was initiated by International Protocol Chairman Soror Janelle Rush. An announcement was made to remove technicians and any non-sorority members in the room, for this portion of the agenda. The ceremony took a pause due to Vice President Kamala Harris speech. The Ivy Beyond the Wall Ceremony proceeded the following morning at 7:30AM.

Madam Vice President began her speech at 11:43AM. She discussed politics of the nation such as tax cuts, high speed internet for children, resources for families with disabilities, administration investing millions into HBCUs, racial bias in buyer appraisal, better representation in federal courts, and assault weapon bans. The speech ended at 12:20PM.
