2013 Internal Audit Review and Recommendations

The Audit Committee conducted an audit of the 2013 Pecunious Grammateus and Tamiouchos financial records. The standards set forth in this audit are from the Fiscal Fitness Guide to Chapter Financial Procedures and Rho Kappa Omega Chapter Bylaws. In addition, a review the 2009 Audit Committee's Recommendations, the 2011 and 2012 Financial Audits were considered. The goal of this audit is to determine the adequacy, completeness and accuracy of the financial record maintained by the chapter's financial officers.

Records Reviewed

- Bank Statements (Operating, Fundraising and Scholarship Accounts)
- Pecunious Grammateus Reports (January 2013 December 2013)
- 2013 Pecunious Grammateus Ledger
- 2013 Pecunious Grammateus Receipt Books
- Tamiouchos Reports (January 2013 December 2013)
- 2013 Tamiouchos Ledger
- Bond Insurance Document
- 2013 Transmittal Forms from PG to Tamiouchos
- Confirmation Printouts of 2013 Paypal Transfers
- 2013 Check Stubs with voided checks attached
- Voucher Reimbursement Requests

Officers' Internal Controls

The standards set forth in the chapter's governing documents were used to ensure that the financial records are in compliance. The following internal controls were reviewed and used to evaluate completeness and integrity of the chapter's financial records.

Pecunious Grammateus Internal Controls

- All funds collected are recorded and maintained in a Cash Receipt Journal.
 - Funds collected were recorded in an electronic cash receipt log. At some point the handwritten journal referenced in the 2009 Internal Audit Review was discontinued and an electronic spreadsheet was created and maintained. The 2011 Audit Report and the 2012 Audit Comparison Report did not reference the Cash Receipt Journal.
- Receipts given for all income received.
 - This standard is stated in the Fiscal Fitness Guide to Chapter Financial Procedures and recommended in the 2009 Internal Audit Review & Recommendation. After reviewing the receipt book it was determined that most receipts were provided to the payee, some receipts were found in the fundraising receipt book.
- All transactions were recorded in a triplicate receipt book.
 - The Chapter Bylaws state that all receipts should be recorded in a triplicate receipt book.
 The receipt books used during the audit period were triplicate receipt books. One receipt

- was provided to payee, one provided to Tamiouchos and stapled in Tamiouchos binder with transmittal form that correlates with the receipt.
- Pecunious Grammateus transferred all collected funds to Tamiouchos within five (5) to seven (7) days of receipt.
 - The Pecunious Grammateus reports were analyzed to ensure that all funds collected were transferred to the Tamiouchos within five (5) to seven (7) days of the date received. The documentation showed that funds were transferred within the required timeframe most of the time. At times transmittals were done more than once in a given week.
- Cash Receipt Journal correspond with receipts.
 - Electronic Cash Receipt Journals are maintained and were reviewed. Cash receipt journals corresponded with receipts and transmittal forms.
- Monthly reports submitted to Chapter.
 - Monthly reports were submitted to the Chapter for review, a copy submitted to Grammateus and filed in Pecunious Grammateus and Tamiouchos Binders.
- Receipt books and handwritten receipt journals are separated from prior year.
 - The 2009 the Audit Committee recommended that the receipt book and receipt journals should only reflect the current fiscal year. The 2011 and 2012 internal reviews did not reference this issue. In 2013, the receipt book for operating had 21 receipts written for 2014 calendar year. The receipt journal exclusively listed 2013 activity.
- Cash Receipt Journal describe the activity that occurred.
 - The electronic Cash Receipt Journals list a description of the funds collected and activity the funds were collected for.

Tamiouchos Internal Controls

- Funds received from the Pecunious Grammateus are to be deposited into the bank within five (5) to seven business days of receipt.
 - o Deposits were usually made within five (5) to seven (7) days of receipt.
- Provide monthly reports to the Chapter.
 - Monthly reports were provided to the chapter. The monthly reports reflect the total income, disbursements, opening and closing balance on each report.
- Tamiouchos and Basileus or alternate authorized signer is required to sign all checks
 - Checks were signed by both officers. Alternate authorized officer signed checks in an emergency if Basileus was not present.
- Maintain a running list of outstanding disbursements and deposits
 - The Tamiouchos Reports reflect all outstanding disbursements through footnotes.
 Replacement checks were noted on stubs and also in notes.
- All invoices and signed contracts should be attached to a voucher request.
 - Voucher-Reimbursement Requests were reviewed. Disbursements were accompanied with a voucher. Original receipts were attached to the voucher with the proper approval.

Overall Assessment

This auditor found that the Pecunious Grammateus and Tamiouchos maintained the Rho Kappa Omega Chapter's financial records well. Funds were collected, receipts were provided to payees, funds were properly recorded, transferred to Tamiouchos, deposited in bank accounts, documented in journals, presented to the chapter monthly. Check books for operating and fundraising accounts were maintained in separate receipt books and presented to auditor for review. Vouchers, receipts and check stubs clearly noted a sound system of reviewing at every level.

Audit Recommendations

- 1. Pecunious Grammateus to ensure all receipts written are given to the payee at all times.
- 2. The PKQ Bylaws need to be changed to reflect that the handwritten journals are discontinued and replaced with electronic spreadsheets/journals.
- 3. Pecunious Grammateus to continue maintaining a triplicate receipt book. The original copy is given to the payee. The second copy is given to the Tamiouchos for record keeping and to be used as a receipt of the transfer fund. The third copy remains in the receipt book.
- 4. The Tamiouchos report should continue to reflect all outstanding deposits with a total noted and the explanation of status of follow up.
- 5. Tamiouchos and Pecunious Grammateus should continue to list all transactions in chronological order and should group transactions by "event" or "activity" (e.g. "Bowling Night", "Dues", etc.) as currently being done.
- 6. Timely transfer of funds from Pecunious Grammateus to Tamiouchos within five (5) to seven (7) business days of receipt and from the Tamiouchos to the bank within five (5) to seven (7) business days of receipt should continue as outlined in the current Rho Kappa Omega Chapter Bylaws revised in 2014.
- 7. Pecunious Grammateus and Tamiouchos to maintain binders inclusive of all monthly reports, and electronic journals. The Tamiouchos binder would include required reports detailed in this audit, copies of transmittal forms, receipts, bank statements, check stubs, etc. The monthly reports maintained in each officer's binder are a backup copy to the financial report submitted to the Grammateus monthly. The Grammateus' copies are bound with other official chapter records.

To Madam Regional Director. It is my pleasure to present to you on behalf of the Evaluation Committee. I am soror Tanya Brown, evaluation committee vice-chair, from Rho Kappa Omega, Hudson County, New Jersey.

The Evaluation Committee had four objectives

- 1. To review and revise NARC 2011 questions and adapt them to the NARC 2015 conference.
- 2. To create an evaluation process utilizing survey monkey.
- 3. To provide a means for our Diamond and Golden Sorors to complete a NARC 2015 evaluation on site.
- 4. To provide a summary of survey results.

Accomplishments:

As result of several phone conferences and emails the evaluation questions were reviewed, revised and streamlined to reflect the NARC 2015 conference. Questions were submitted to the NARC Technology Committee who facilitated creation of the evaluation on survey monkey. They have advised us that at the conclusion of the conference all sorors in attendance will receive an email link to complete an evaluation via survey monkey.

In an effort to support our National Program Target IV which is Environmental Ownership through Acts of Green Program and in support of our Regional Director's commitment to reducing cost we elected not to provide copies of the evaluation. But instead, offered assistance with completing an onsite electronic evaluation.

We reached out to sorors and received 7 volunteers from Cluster IV. These volunteers offered to help sorors complete an electronic evaluation by bringing their laptops, tablets or iPads to the Diamond and Golden cafe on Saturday night 10-11 pm and Sunday morning 8-11 am. Also, a sign was posted in the Café with the times of such help.

All Sorors are encouraged to provide feedback. Chapter Basili, at May chapter meetings, are encouraged to provide assistance to members in accessing emails and the evaluation survey to ensure everyone has a voice. Our Madam Regional Director wants to hear from you. Our opinions count.

Here is a summary of our efforts. In total there were 7 sorors who assisted 19 Golden and not so tech savvy sorors in completing a conference evaluation survey. There several reasons why the numbers may have been low. One is that Saturday night following the Gala is not a good time, as it is too late and no one wants to stay to do a survey. Two, Sunday morning many are

Lastly, not enough publicity was given to the assistance, as it wasn't advertised in advance in registration material, conference guide, email, or phone app. Therefore, the following should be considered for next year:

- 1. Offer some hard copies of evaluations to be given out at the start of the conference perhaps on check in- offer it to Diamond and Golden Sorors.
- 2. Advertise assistance information in registration packet, conference guide, and email and phone app.
- 3. Post a sign, listing assistance information, in the Golden & Diamond Café on day one of conference.
- 4. Assign volunteers to help with lap tops, iPhones etc and assign volunteers to recruit or bring sorors to the area.
- 5. Have volunteers available at hotels to assist when sorors are checking out.

Finally, sometime following the conclusion of the evaluation period, which is scheduled to end May 19th, a summary of feedback will be provided to the Regional Director.
