The Statement of Financial Operations (End of the Year report) was prepared by the former tamiouchos and submitted to Corporate Office on January 30, 2017.

Special thank you to Madam Basileus for coming to Morris County (twice) to submit sorors' Per capita and EAF to Corporate office before February 1st.

IRS back taxes owed by the chapter is \$1,715.93 (2013 and 2015). This amount consist of \$352.93 - 2013, \$0 – 2014, \$1,363.00 – 2015. The preceding amount doesn't include our 2016 tax liability. The first payment is due on January 1, 2018.

2016 Fundraising Profit (ticketed events) will be reported on by the Audit Committee.

2016 outstanding assessment: (7) sorors are indebted to the chapter. The total indebtedness is \$680.00.

PNC Banking Policy changes: Madam Basileus Wood-Stradford and Soror Powell met with PNC banker, Elizabeth Caicedo at the Journal Square location. Ms. Caicedo reviewed Rho Kappa Omega accounts and indicated that the new April 2017 policies are not applicable to the chapter.

ExtraSpace Storage: Madam Basileus was able to negotiate a \$25 one-time credit and monthly rental reduction. Through her negotiation, the chapter was able to reduce the annual cost from \$1,668 to \$1,544.50. Additionally, the chapter received an extra month free (January 2018).

Palitto Insurance Agency provides bonding for (4) Rho Kappa Omega officers. These officers include the Basileus, Tamioucos, Pecunious Grammateus, Fundraising Chairman. The current bond expires 2/28/2017.

Effective 3/1/17, the following Officers/Committee Chairman will be bonded: Basileus, Grammateus, Tamiouchos, Pecunious Grammateus and Fundraising Chairman.

Budget Request Form will be customized with a breakdown of the committee's chairman and officers' previous years' budget and the Budget and Finance Committee will meet with everyone in person by September 1st.

Budget Update: The current fundraising balance is not enough to cover the 2017 Program Budget. The committee has decided to wait until the 2016 Fundraising profit has been reported on by the Audit Committee before taking action.

2017 Goals:

1. To prepare and present detailed, summary and year-to-date financial reports for the following Rho Kappa Omega's accounts; Operations, Program/Fundraising and Scholarship.
2. To educate chapter members regarding internal and external financial policy changes impacting the chapter's current and future growth potential.
3. To review the External and Internal Audit reports to determine how to integrate recommendations into the chapter financial procedures.
4. To create an electronic Chart of Accounts combining all account codes into one complete list.

 - f) Offer constructive criticism and avoid unsisterly conduct.
6. Actively participate in chapter meetings, committee meetings, chapter activities and events.
7. Adhere to the current financial and fundraising procedures of Alpha Kappa Alpha Sorority, Incorporated and Rho Kappa Omega Chapter.
8. Maintain good financial status by paying your dues and assessments per the chapter bylaws.

Ask yourself... "What kind of chapter would this be if all of the members were just like me?"
