<u>Highlights Directorate Meeting</u>- met in Phoenix, Arizona from February 25- 28, 2016, Membership has exceeded 65, 000 active members, over 12, 400 ASCEND students have been served, 200,000 book bags collected, 1 million given to HBCU's, 600 plus playground refreshed, 10 chapters chartered, MIP changes will be in 2017, Per capita will increase.

Proposed changes to AKA- directed from Soror Darcell Medley-Stokes: proposed Constitution and Bylaws amendments form from 2 chapters in North Atlantic region.

Motion made by Soror Sobande Afolabi to accept recommendation number 2 to the Proposed Constitution and Bylaws amendment as presented- Motion carried- delegates will vote yes at NARC.


